Purpose:

The purpose of this collaboration is to ensure the placement of students that have completed their pre-sea training from MOHAMED SATHAK ENGINEERING COLLEGE (MARINE) by Casablanca shipping Pvt. Ltd.

Casablanca shipping pvt.ltd will be responsible for placement of candidates on board in accordance to the criteria set out by both parties within the MOU.

Wherein ... Casablanca shipping pvt.ltd ,Mumbaiwill be responsible for ensuring that all candidates will be given all training and documents needed for placement in accordance to rules set out by MMD.

Duration:

This Memorandum shall commence on 01st AUG 2021.... and continue for the period of twelve months and then will be reviewed.

This memorandum may be terminated by either party giving the other party one month notice in writing.

Meetings and Reporting:

To accomplish the purpose set out by this MOU, both parties will communicate via emails and phone calls regularly to discuss candidates and any issues around placement. A monthly email will be sent to MOHAMED SATHAK ENGINEERING COLLEGE (MARINE) by Casablanca in order to update the institute about recent placements.

Boarding and lodging:

If the candidates are required to come to Mumbai to submit documents or join the vessel, all boarding and lodging fee will be funded by the candidate itself.

Procedure of placement of candidates:

- As per the policies and procedure of Casablanca shippingPvt.Ltd, every student will be interviewed and all documents of selected students will be held by Casablanca shipping pvt.ltd.
- II. Once the candidates are confirmed (submitted their passport and cdc) we will actively look for a placement for the relevant candidates. Once confirmed for a particular vacancy there will be a cancellation fee of 25,000 INR if the candidates decide to withdraw their documents for any reason after the commencement of the visa process.
- III. Final payment will be taken only when candidate is joining, contracts, Visa copy and all other relevant documents will be handed over to the candidates at this time. All payment will have to be in cash and the DD amount of 25,000 INR should be drafter to Casablanca shippingPvt.Ltd.
- IV. Placement of candidate will be within 30 days from the time the candidate submits his passport and CDC to Casablanca shipping pvt .ltd.
- V. If the candidate has to return due to the ship going into 'scrap' Casablanca shipping pvt.ltd. will take full responsibility for placing the candidate again and the only charge incurred by the candidate will be that of the airfares to rejoin another vessel.

The Parties undertake to act in good faith with respect to each other's rights under this Agreement and to adopt all reasonable measures to ensure the realization of the objectives of this Agreement.
