6. Faculty of Architecture and Planning

7. Faculty of Science & Humanities

8. Faculty of Management Science

The Functions and powers of the Board of Studies are as follows:

### TERM OF OFFICE

Members of the Board of Studies shall be appointed by the Vice – Chancellor and shall hold office for a period of three years or such period as may be fixed at the time of the appointment provided that the Vice – Chancellor may declare any members of a Board to have vacated his membership if he/she is absent for two consecutive meetings.

## **FUNCTIONS**

It shall be the duty of each Board of Studies to consider and report on any matter referred to it in accordance with the Laws (Status, ordinances and Regulations) of this University, by the Syndicate or by the Academic Council or the Faculty concerned with the subjects with which it deals.

#### **POWERS**

Each Board shall have power to recommend to the Academic Council, persons suitable for appointment as Examiners in the subject with which it deals, to recommend text books and wherever necessary to consult specialists who are not members of the Board, to make recommendations with regard to courses of study and examinations in the subject with which it deals.

#### MEETINGS

Meetings of the Board of Studies shall be convened by the Chairman of the Board at such times as may be necessary or on the written request of not less than one – third of the members serving on the Boards, at the time. Where, in the temporary absence of a Chairman a meeting of the Board of Studies is required to be convened, for the purpose of dealing with any urgent University business, the Senior Professor among the Board, will act as Convener and shall take the necessary action.

The Chairman shall preside at all meetings of the Board of Studies and in the absence, of Chairman at any particular meeting the members present shall elect their own Chairman.

#### QUORUM

Fifty percent of the current membership shall form a Quorum.

#### VOTING

\* The special invitees of each Board visit not have any rights for voting in the mactuag of the Board of Sitidies.
